Certified Recovery Specialist (CRS) Training Series 2024

The CRS/CFRS training series will be held over two weeks beginning 10/7/24 and concluding 10/18/24. The training is funded by SW Corner's ARC INSPIRE initiative in collaboration with PaPSC. There is no cost to attend. Priority seating will be reserved for Beaver County residents until 9/8/24. Upon completion of the training, funding assistance is available, as may be necessary, for initial application and certification fees (\$150 for either CRS/CFRS).

To Apply:

- Candidates must begin by creating an account at <https://www.pacertboard.org/>
- Once an account is created by you AND approved by the PCB, candidates must apply for the class at <https://www.pacertboard.org/class/recovery-specialist-295>
- PLEASE be sure to fill out application ENTIRELY with up-to-date information (working phone number, email, current address, etc.)
- Once application is reviewed and pre-screening done via phone, you will be directed to PA Job Training for Beaver County, Inc. at PA CareerLink® Beaver County to complete eligibility process.
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

*The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:15 am and expect to be in class to 4:30 pm each day.

	The fifth session of the RSC will conclude the discussion on ethics and professionalism. The day will conclude with beginning the discussion on Substance Use Knowledge.
