

Certified Recovery Specialist (CRS) Training Series 2025

The CRS/CFRS training series will be held over two weeks beginning 2/17/25 and concluding 2/28/25. The training is funded by Partner4Work's ARC INSPIRE initiative in collaboration with UPMC/CCBHO and there is no cost to attend. Priority seating will be reserved for Allegheny County residents who are veterans, mothers, or re-entrants until 1/20/25. Upon completion of the training, funding assistance is available, as may be necessary, for initial application and certification fees (\$150 for either CRS/CFRS).

- PLEASE be sure to fill out application ENTIRELY with up-to-date information (working phone number, email, county of residency, current address, etc.)
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.
