

Certified Recovery Specialist (CRS) Training Series 2025

The CRS/CFRS training series will be held over two weeks beginning 3/3/25 and concluding 3/14/25. The training is funded by PaPSC's ARC POWER initiative, in conjunction with our partner Westmoreland & Fayette Counties Workforce Investment Board, and there is no cost to attend. Upon completion of the training, funding assistance is available for application fees for initial certification fees (\$150 for either CRS/CFRS).

- Candidates must begin by creating an account at https://www.pacertboard.org/
- Once an account is created candidates must apply for the class at https://www.pacertboard.org/class/recovery-specialist-326
- Once application is reviewed, you will be contacted via phone to conduct a pre-screening to determine eligibility, so please be sure to include working number
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

*The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:15 am and expect to be in class to 4:30 pm each day.
