



## Certified Recovery Specialist (CRS) Training Series 2025

The 10 day CRS/CFRS training series will be held Thursdays and Fridays beginning 4/3/25 and concluding 5/2/25. The training is funded by PaPSC's ARC POWER initiative Project POWER and in collaboration with the Wayne-Pike Workforce Alliance. There is no cost to attend. Students will not be responsible for the \$150 testing/PCB application fee. This will be covered by PaPSC.

- Students may test for CRS Certification after completing 78 hours of training, including 66 classroom hours and 12 hours of work outside the classroom.

	The second session in the RSC will conclude the discussion of the role of the Recovery Specialist (RS) and begin the review of communication and professional skills of the RS.	
4/10/2025	RSC03 - Communication and Motivational Interviewing	7
	The third session of the RSC will conclude the discussion of the role of the RS and introduce Motivational Interviewing.	
4/11/2025	RSC04 - Stages of Change and Ethical Considerations	6.5
	The fourth session of the RSC will continue the discussion of Motivational Interviewing and review the Stages of Change. Ethical responsibility and professionalism will also be discussed.	
4/17/2025	RSC05 - Ethical Responsibility and Professionalism	6.5
	The fifth session of the RSC will conclude the discussion on ethics and professionalism. The day will conclude with beginning the discussion on Substance Use Knowledge.

	The sixth session of the RSC will be an in-depth discussion on substance use.	
4/24/2025	RSC07 - Co-Occurring/Mental Health and Recovery Planning/Collaboration	6.5
	The seventh session of the RSC will discuss co-occurring disorders and mental health, as well as begin a discussion on recovery planning and collaboration.	
4/25/2025	RSC08 - Recovery Planning/Collaboration and Other Types of Support	6.5
	The eighth session of the RSC will conclude discussion of recovery planning and collaboration. Additionally, other types of support a recovery specialist can provide will be reviewed, including non-clinical support groups, digital recovery support, and advocacy.	
5/1/2025	RSC09 - Advocacy and Cultural Competency	7
	The ninth session of the RSC will conclude discussion on advocacy and begin a discussion on cultural competency.	
5/2/2025	RSC10 - Cultural Competency, Safety, and Self-Care	7
	The tenth and final session in the RSC will conclude the discussion of cultural competency and discuss safety and self-care for the recovery specialist.
