

## Certified Recovery Specialist (CRS) Training Series 2025

The CRS/CFRS training series will be held over two weeks beginning 3/31/25 and concluding 4/11/25. The training is funded by TCWIB's ARC INSPIRE initiative and there is no cost to attend. Priority seating will be reserved for Indiana, Butler, and Armstrong County residents who are veterans, mothers, or re-entrants until 2/24/25. Upon completion of the training, funding assistance is available for application fees for initial certification fees (\$150 for either CRS/CFRS).

- Candidates must begin by creating an account at https://www.pacertboard.org/
- Once an account is created candidates must apply for the class at https://www.pacertboard.org/class/recovery-specialist-325
- Once application is reviewed, you will be contacted via phone to conduct a pre-screening to determine eligibility, so please be sure to include working number
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.
