

## Certified Recovery Specialist (CRS) Training Series 2025

The CRS/CFRS training series will be held over two weeks beginning 5/5/25 and concluding 5/17/25. The training is funded by Partner4Work's ARC INSPIRE initiative in collaboration with UPMC/CCBHO and there is no cost to attend. Priority seating will be reserved for Allegheny & Greene County residents who are veterans, mothers, or re-entrants until 4/6/25. Upon completion of the training, funding assistance is available, as may be necessary, for initial application and certification fees (\$150 for either CRS/CFRS).

- Candidates must begin by creating an account at <a href="https://www.pacertboard.org/">https://www.pacertboard.org/</a>
- Once an account is created by you AND approved by the PCB, candidates must apply HERE
- PLEASE be sure to fill out application ENTIRELY with up-to-date information (working phone number, email, county of residency, current address, etc.)
- Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.

<sup>\*</sup>The hours listed here are the minimum hours necessary to complete the curriculum. Actual classroom time may vary from week to week depending on class flow. Students should arrive by 8:15 am and expect to be in class to 4:30 pm each day.
