

Certified Recovery Specialist (CRS) Training Series 2025

The CRS/CFRS training series will be held over five weekends (Friday 3 pm to 9 pm and Saturday 9 am to 4 pm) beginning 3/21/25 and concluding 4/19/25. The training is funded by the Pennsylvania Department of Drug & Alcohol Programs (DDAP) through the Region 5 Recovery Hub and hosted by Franklin/Fulton County Office of Drug & Alcohol Abuse. - Students may test for CRS Certification after completing 78 hours of training including 66 classroom hours and 12 hours of work outside the classroom.
